Chicago's Merit School of Music is a nationally accredited music school helping young people transform their lives by removing barriers to high-quality music education. Our 125 passionate and experienced teaching artists engage nearly 5,000 students annually in group and individual instruction, and through two signature programs: the community-based Bridges: Partners in Music (Continued on Schedule O, Statement 2)

The Merit Music in Communities (MMiC) program provides beginning and intermediate music instruction to more than 2,000 students at dozens of community sites throughout Chicago. MMiC programming varies by site, and can include group instruction in orchestra, band, choir, general music, early childhood or instrument specific classes such as guitar or percussion.

4b (Code:) (Expenses \$ 1,783,251 including grants of \$ 506,856) (Revenue \$ 1,392,392)

Private Lessons offer weekly 30, 45 or 60 minute music lessons to approximately 900 students of all ages and skill levels. Private lessons provide a potentially transformative benefit for students who have demonstrated that they have the dedication and abilities to reach high levels of musical achievement. Access to private lessons can be a key factor in determining whether a student progresses beyond the intermediate-level to more advanced levels of musical study.

The Instrumental & Vocal Music Program provides group music instruction for approximately 650 beginning and intermediate musicians in grades K-9. The program features after-school programming for String, Band, Piano, Guitar and Voice.
